What you need to do

Your endorsement was based on the information you gave us. Your organisation's fund, authority or institution should regularly review its endorsement as a deductible gift recipient. We recommend a yearly review. If there are any changes (for example, to governing rules, structure or operations) and you are no longer entitled to endorsement, you must notify us before or as soon as possible after the event.
